I have read all the Girl Scout Cookie Program materials and agree to:

- Have my daughter, and anyone associated with my daughter, not begin taking orders until January 14, 2011.
- Be responsible for ALL cookies ordered by my daughter, both initial orders and re-orders.
- Sign a receipt for all cookies picked up and all monies turned in to the council.
- Provide my daughter with supervision and adult guidance.
- Council has the right to adjust (down) any girl's order and/or to request to see my daughter's order card.
- Be responsible for turning in all money collected for cookies by Friday, March 18, 2011 by 5 pm.
- Understand that cookies cannot be returned, but damaged boxes can be replaced if I contact Juliette Program Specialist before the end of the program.
- I understand that my daughter can not officially change her Girl Scout Juliette status between January 28, 2011 (when initial orders are submitted) and April 29, 2011 (when council has reconciled cookie paperwork).
- She can start participating in troop activities if troop placement is found during that time.

Furthermore, I understand that because unsold cookies cannot be returned, they are the responsibility of the person signing the receipt. So, I agree to be responsible for the Girl Scout Cookies received by my daughter and the money collected by her. I understand that if I do not comply with the sale dates and rules as outlined above or turn in all money my daughter owes, she will not be able to participate in any future Council sponsored Girl Scout activities.
