Troop Training

Training is required for troops to receive their cookie supplies and to participate in the program. Online training is live in gsLearn and can be found by searching “634 Troop Cookie Manager Training 2022” in the content library. You will receive a completion certificate once you complete the online training. The certificate should be provided to your service unit cookie team to receive program supplies.



Participation Requirements for Troops:

Please remember cookie managers must complete training and submit a [Volunteer Position Agreement](#) prior to troop participation. An [ACH Authorization Form](#) is also required if the troop did not participate in 2021 product programs or bank information has changed since. Troops should refrain from submitting the ACH form if they participated in the 2021 cookie or fall product programs and banking information has not changed.

Girls must be registered for MY22 and in a troop that meets participation requirements. They must also complete a Cookie Permission Form. Cookie managers may collect paper forms from their service unit, or families can submit a [digital form](#), found at www.girlscoutshcc.org/resources.

Smart Cookies



Troops will get access to Smart Cookies beginning January 10, 2022. Users must meet registration requirements before they receive access to the system. Please ensure noreply@abcsmartcookies.com is in your safe senders list so emails don't end up in spam. Girls will be uploaded beginning January 10, but will not be able to access the platform until January 14. Troop uploads will occur every Tuesday and Thursday, and girl uploads will occur Mondays, Wednesdays, and Fridays. This means if troops or girls meet eligibility requirements after the initial upload, they will be added on the following scheduled upload date.

Smart Cookies Payment System

The Smart Cookies payment system was new for the 2021 cookie program. The integrated payment system allows customers to pay for cookies with a card for all order types. Fees are normally 2.8% + \$0.12 per transaction, but GSHCC will cover these fees, once again, for the 2022 cookie program! Troops are responsible for all other payment system fees.

Booths & Alternatives to Booths

GSHCC is currently planning for booths, but due to COVID-19, please ensure your troop members are keeping up with the latest updates.
