IN CIRCUMSTANCES IN WHICH A CONFLICT OF INTEREST IS UNCLEAR TO STAFF OR OTHER GSHCC MEMBERS, A JUDGEMENT REGARDING THE POTENTIAL CONFLICT WILL BE MADE BY THE GSHCC BOARD OF DIRECTORS FOR WHICH A RECORD WILL BE AVAILABLE IN THE MINUTES OF THE BOARD OF DIRECTORS MEETING.
