Dates to Remember

Prior to Participating

Complete a <u>Permission Form</u>. Enter "customercare@girlscoutshcc.org" in the '*Troop Fall Product Manager Email*' field. This will create a case for you and you will hear back from GSHCC with next steps.

September 20

Fall Product Program begins! Click link in launch email from the council, click on M2 link from the council website at www.girlscoutshcc.org/fallproduct, or go to www.gsnutsandmags.com/gshcc to get started.

October 20

Fall Product Program Ends.

Do not enter Girl Delivered online nut orders as these are already in the system.

October 23

Reward choices due in M2 system no later than this date.

November 13-20

Candy/nut items delivered to service units. Check with your service unit fall product manager for location, date and time to pick up your candy/nut items and rewards.

November 22

Last day to deliver product to customers. Communicate delivery time frame with customers at time of order

November 27

Estimated reward delivery to service units. Check with your service unit volunteer for location, date and time to pick up reward items.



What Girls Need to Participate

Girls must be registered for the 2024 MY and have a signed <u>Permission Form</u> on file with GSHCC. The permission forms and other resources are also available online at www.girlscoutshcc.org/fallproduct.

How Girls Participate

Girls wishing to participate individually can participate in Girl Delivery and Direct Ship only. They cannot accept cash or checks. This makes participating even easier - no money or forms to turn in! For participation electronically, internet access and parental supervision is required.

Participating Online

Beginning September 20, girls can create an online account in the M2 system (see details on right for more information on getting started).

Within her online account, she creates an avatar with her own virtual likeness, enters e-mail addresses and creates a personal message to send to family and friends. As a way to increase her sales, we also suggest she record her voice for her avatar or upload a personal video explaining what she is learning and what her goals are. She then launches her campaign and her personal message is sent with links for her customers to shop for magazines and/or candy/nut items.

Girls should create their online account and send out emails early in the program to allow maximum time for their customers to make a purchase.

Payment is collected at the time of order via credit card for all products ordered online (including Girl Delivered candy/nut items). Direct Ship items and magazines are shipped directly to customers.

All orders placed online, including Girl Delivered orders, are automatically added to the M2 system so parents need not record/enter any online sales.

Juliette Pathway Credits

Beginning at \$50 in sales, girls will earn \$5.00 for every \$50 in sales! Funds will be provided to girls on Juliette Pathway Credit cards. Pathway Credits may be applied towards GSHCC events, day and sleepaway camps, membership registration fees for girls, and in-store GSHCC shop purchases. Eligible events are listed on the activities calendar at girlscoutshcc.org. In accordance with the IRS, individual girls cannot earn proceeds on a per dollar basis and cannot be given proceeds in the form of a gift card. Please see Volunteer Essentials for details.
